The Mayor and Burgesses of the London Borough of Barking and Dagenham (in this Order called 'the Acquiring Authority') hereby makes the following Order:-

1. Subject to the provisions of this Order, the Acquiring Authority is under Section 17 of The Housing Act 1985 hereby authorised to purchase compulsorily the land and dwellings described in paragraph 2 for the purpose of the provision of housing accommodation
- 2(1) The land authorised to be purchased compulsorily under this Order is the land described in the Schedule and delineated and shown coloured pink on a map prepared in duplicate, sealed with the common seal of the Acquiring Authority and marked "Map referred to in the London Borough of Barking and Dagenham (Gascoigne East Phase 1 and 2, Barking) Compulsory Purchase Order 2015".
- 2(2) There are no new rights to be purchased compulsorily under this Order.
