COMPULSORY PURCHASE ORDER 2018

SECTION 17 OF THE HOUSING ACT 1985

AND

THE ACQUISITION OF LAND ACT 1981

The Mayor and Burgesses of the London Borough of Barking and Dagenham (in this Order called the 'Acquiring Authority') hereby makes the following Order:-

1. Subject to the provisions of this Order, the Acquiring Authority is under Section 17 of the Housing Act 1985 hereby authorised to purchase compulsorily the land and dwellings described in paragraph 2 for the purpose of the provision of housing accommodation and facilities to be provided in connection with the housing accommodation including a new primary school.
2. (1) The land authorised to be purchased compulsorily under this Order is the land described in the Schedule and delineated and shown coloured pink on a map consisting of a folio of four sheets containing plans marked "Map 1 of 4", "Map 2 of 4", "Map 3 of 4" and "Map 4 of 4" respectively, prepared in duplicate, each sealed with the common seal of the Acquiring Authority and marked "Map referred to in the London Borough of Barking and Dagenham (Gascoigne Estate (East) Phase 3, Barking) Compulsory Purchase Order 2018".

(2) There are no new rights to be purchased compulsorily under this Order.
