Introduction

This planning advice note (PAN) provides guidance for land developers, businesses, training providers and residents about local labour and local business agreements.

Barking and Dagenham is about to see massive change, as we improve existing parts of the borough and create new communities on 'brownfield' land (land that has been built on before). We want to make sure that local people and businesses benefit from the improvement of the area. One way to make sure this happens is for us to make local agreements with land developers. The agreements will mean:

- more jobs and training for local people; and
- more opportunities for local businesses to compete for contracts to work on new land developments.





Local labour agreements

We make local labour agreements to benefit local residents. These agreements can:

- give local people access to jobs which are created while the new developments are being built;
- give local people access to jobs which are created once the developments are finished and being used; and
- get developers to give money to pay for training courses that give local people the skills they need to make the most of new job opportunities.







Local business agreements

We make local business agreements to benefit local small and medium-sized enterprises (SMEs). These agreements can:

- give local SMEs opportunities to compete for contracts to work on development sites; and
- give SMEs opportunities to provide services to whoever uses the development when it has been built.



What types of agreements will we make with developers?



1. Training for local people

We will ask developers to contribute to training for local people to access new job opportunities. We will ask for contributions if:

- there is a shortage of trained local people to fill the skilled jobs;
- there are shortages across the whole industry that may affect how the development is used;
- we need to increase the number of training places a local training provider makes available;
- we need to set up a new course to train local people in new skills; or
- any new employees need ongoing training.

Examples of training that developers could support are:

for local people to get the qualifications they need to work on building the development or to work for the business that later uses the development;

- training to improve local residents' skills so they can access more skilled jobs;
- training for young people before they go on to do an apprenticeship; and
- work-based training (training while you are doing the job) to learn new skills to get new qualifications.

2. Agreements for local job advertisements and employment

We will recommend that developers advertise jobs locally or use the local job brokerage service to promote local employment. Services the job brokerage service provides could include:

- keeping in contact with the developers' preferred employment agencies and training providers to find local people suitable for the job;
- assessing how suitable and experienced people applying for the job are;
- regularly visiting developers and building companies to check on the progress of any new employees;





- agreeing a way for developers and building companies to let the job brokerage service know about new job vacancies; and
- opening an employment office on large development sites.

3. Agreements for jobs for local people

We may recommend that the developer makes an agreement to employ local people for building the development — this is known as a local labour clause. The clause may be passed on to whoever uses the development when it is finished.

Under the local labour clause, the developer will:

- do their best to employ a percentage of its workforce from local residents; and
- do their best to take on local apprentices.



4. Places for trainees

We will encourage the developer and its building companies to take on trainees from local colleges. We may also ask developers to give money for ongoing support and training.

5. Local business agreements

We may set up a local business agreement with developers and building companies so that they tell us about opportunities for local businesses to compete for contracts.

We will support local businesses and social enterprises (small not-for-profit businesses that benefit the local community) to benefit from the opportunities that will come from major development projects in the area. We will help local companies to bid for local contracts and we will support the companies to deliver the contracts when they win them.
