

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF BARKING AND DAGENHAM (SPECIAL EVENTS) (TEMPORARY PROHIBITION OF VEHICULAR TRAFFIC) (VARIOUS ROADS, BARKING AND DAGENHAM) ORDER 2022

The Council of the London Borough of Barking and Dagenham in exercise of their powers under Sections 16A of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling and amending legislation and powers, hereby make the following Order:-

1. This Order shall come into operation on each of the dates and at the times set out in Articles 3-6 to this Order and may be cited as The London Borough of Barking and Dagenham (Special Events) (Temporary Prohibition of Vehicular Traffic) (Various Roads, Barking and Dagenham) Order 2022.
2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
3. Save as provided in Article 7 hereof, no person shall cause or permit any vehicle, including pedal cycles, to enter the following lengths of road on Thursday 2nd June 2022 between the hours of 7.00am-10.00pm:
 - a. Junction Road West, both sides, from its junction with Heath Road to its junction with Cecil Road.
4. Save as provided in Article 7 hereof, no person shall cause or permit any vehicle, including pedal cycles, to enter the following lengths of road on Friday 3rd June 2022 between the hours of 7.00am-10.00pm:
 - a. Woodlands Avenue, both sides, from its junction with Farrance Road to the northern property boundary of No.1 Woodlands Avenue.
 - b. Brendon Road, both sides, from its junction with Temple Avenue to its junction with Grosvenor Road.
5. Save as provided in Article 7 hereof, no person shall cause or permit any vehicle, including pedal cycles, to enter the following lengths of road on Saturday 4th June 2022 between the hours of 7.00am-10.00pm:
 - a. Hatfield Road, both sides, between its junction with Chaplin Road and Cartwright Road and its junction with Lullington Road.
 - b. Croxford Way, both sides, from its junction with Horace Avenue for its entire extent.
6. Save as provided in Article 7 hereof, no person shall cause or permit any vehicle, including pedal cycles, to enter the following lengths of road on Sunday 5th June 2022 between the hours of 7.00am-10.00pm:
 - a. Tolworth Gardens, both sides, from its junction with Hathaway Gardens to its junction with East Road
 - b. Sandown Avenue, both sides, from its junction with Sandown Court to the western property boundary of No.19 Sandown Avenue.
7. Nothing in Articles 3, 4, 5 or 6 of this Order shall apply to:
 - a. Any vehicle being used, in connection with the said event;
 - b. Any vehicle being used, by a statutory undertaker in an emergency where it is necessary by reason of emergency for that vehicle to have access to or to wait or load within the prohibited length of road at a time when the prohibition applies;
 - c. Any vehicle being used for Fire brigade, Police or Ambulance purposes; or


- d. Anything done with the permission or under the direction of a police constable in uniform.
8. The Limited Waiting Mon-Fri 8.30am-5.30pm 2hrs no return within 4hrs bay on Junction Road West, west side, adjacent to No.49 Heath Road on Thursday 2nd June 2022 between the hours of 7.00am-10.00pm shall be suspended.
9. The Business Permit Holders Only (CH) Mon-Fri 7am-6pm bays on Junction Road West at the following locations on Thursday 2nd June 2022 between the hours of 7.00am-10.00pm shall be suspended:
 - a. east side, adjacent to No.52 Kenneth Road.
 - b. west side, adjacent to No.50 Kenneth Road.
10. The Loading Only Mon-Fri 7am-6pm 1hr no return within 2hrs bay on Junction Road West, west side, adjacent to No.49 Heath Road on Thursday 2nd June 2022 between the hours of 7.00am-10.00pm shall be suspended.
11. The Resident Permit Holders Only (CH) Mon-Fri 8.30am-5.30pm bays on Junction Road West on Thursday 2nd June 2022 between the hours of 7.00am-10.00pm at the following locations shall be suspended:
 - a. east side, adjacent to No.51 Heath Road .
 - b. west side, adjacent to No.57 Kenneth Road and No.42 Cecil Road.
 - c. east side, adjacent to No.59 Kenneth Road.
 - d. east side, adjacent to No.44 Cecil Road.
12. The Disabled Badge Holder bays on Woodlands Avenue on Friday 3rd June 2022 between the hours of 7.00am-10.00pm at the following locations shall be suspended:
 - a. west side, outside No.4 Woodlands Avenue.
 - b. east side, outside No.25 Woodlands Avenue.
 - c. west side, outside No.42 Woodlands Avenue.
13. The Resident Permit Holders Only (CH) Mon-Fri 8.30am-5.30pm bays on Woodlands Avenue on Friday 3rd June 2022 between the hours of 7.00am-10.00pm at the following locations shall be suspended:
 - a. south side, outside No.62 Woodlands Avenue.
 - b. south side, outside No.52 to No. 60 Woodlands Avenue.
 - c. south side, adjacent to No.44 Farrance Road.
 - d. west side, outside No.44 and No.46 Woodlands Avenue.
 - e. west side, outside No.6 to No.40 Woodlands Avenue.
 - f. west side, outside No.4 and No.6 Woodlands Avenue.
 - g. east side, outside No.1 to No.5 Woodlands Avenue.
 - h. east side, outside No.7 to No.23 Woodlands Avenue.
 - i. east side, outside No.27 to No.43 Woodlands Avenue.
 - j. north side, adjacent to No.42 Farrance Road.
 - k. north side, adjacent to No.43 Woodlands Avenue.

 - f. south side, outside No.18 to No.28 Brendon Road.
 - g. south side, adjacent to No.63 Temple Avenue.

- ff. south-east side, outside No.43 and No.45 Tolworth Gardens

18. The provisions of this Order shall apply only during such times and to such extent as indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2016.
