


Figure 1: % Applying for and receiving FSM.

Challenges

Decreasing FSM take up

Barriers to claiming

- Loss of funding for schools
- Risk of poorer outcomes for disadvantaged children
- Greater expense to low income or struggling families
- Challenges may increase after end of Universal Credit transition period?
- No true data on those who are eligible but not in receipt of FSM
- In work poverty
- Welfare reform
- English not first language
- Asylum and immigration status
- Cultural barriers
- Bullying
- Receipt of Universal Infant Free School Meals



Employment has risen but so has underemployment and insecure employment.

In-work poverty is on the rise and the cost-of-living crisis continues to worsen.

This might be leading to some families losing out on FSM eligibility despite feeling the pressures of day-to-day budgeting.

Benefits

For Schools:

11 extra Primary students a year (combined effect of FSM and Pupil Premium) = Up to **£21,200** extra funding

This could fund a range of educational resources or Teaching Assistant hours



For Families:

For each child on FSM, up to **£440** every year

For a family with three children, over the course of primary and secondary school, this is a saving of around **£12k**

This could contribute to a mortgage deposit, pay off a loan shark or fix the boiler when it breaks; a big difference!

Joined-Up Approach

Council

- Community Solutions Universal Service is signposting residents eligible for FSM and supporting them with applications.
- Homes and Money Hub has incorporated FSM into their conversations with residents.

Communications

 A simple and attractive FSM leaflet has been designed and is being used by all partners.

Job Centre Plus

- Incorporated FSM into conversations with relevant benefit claimants.
- Added a link to FSM applications in Universal Credit work journals.

Schools

- Piloted the Excel tool to help identify eligible families not claiming FSM.
- Engaged with parents about FSM via a range of universal activities e.g. parents evenings, Christmas fairs, parent workshops, parent coffee mornings, hot school meals parent-child taster events (in collaboration with BDT Catering Services), transitions events, school plays, newsletters and online messaging.
- Undertook targeted follow up engagement with potentially eligible families.

East London Housing Partnership (ELHP)

• Incorporated FSM into their case handling process.

The Tool

The priority for schools was:

Identifying children who are not receiving FSM but are eligible
and engaging with their parents.

Our conversations with some schools led us to design a prototype tool that, along with schools' engagement with parents, can make it easier to identify children who are potentially eligible for FSM.

This is achieved by tracking those in receipt of FSM as well as those who self-identify as not eligible. IDACI (Income Deprivation Affecting Children Index) scores were incorporated in the tool to help schools prioritise parental engagement.

Update

Borough level FSM take up

- Between April 2018 and April 2019 FSM take up increased from 6212 to 8196 children.
- This pilot project plus other actions by DWP, Community Solutions and Elevate (FSM administration) have likely contributed to some of this increase.

Schools' funding slides - footnotes

Pupil census data is used to calculate the annual notional DSG allocation for the Local Authority. This funding is then passported to school using the national funding formula. Pupils who have triggered FSM will continue to attract funding for the next six years through Pupil Premium and the Ever 6 element DSG.

Learning and outcomes – Schools

- A universal approach which engages <u>all</u> parents to raise awareness of FSM and check eligibility, followed by targeted engagement for families who might be eligible appears the best approach
- Dedicated staff responsibility for raising awareness of FSM and (where appropriate) providing support with applications is important
- Regular in-year engagement about FSM at events rather than relying on annual engagement is worth the investment
- Regularly engaging parents about the FSM eligibility criteria provides schools with a more accurate view in-year of parental eligibility. This enables schools to better deploy resources around parental engagement.





Learning and outcomes – Overall

- Supporting FSM take up should be treated as a challenge for the whole system of local public services. Each touch point is a potential opportunity to ascertain eligibility and support FSM application
- Using the right language influences how many families choose to apply. Inclusive, universal language pertaining to the health benefits of school meals, additional funding for schools and in some cases savings for families are much stronger motivators than benefit eligibility





Learning and outcomes – Overall

- A range of myths and misconceptions surrounding FSM needs addressing by all organisations. Improving awareness of FSM across organisations and amongst families enables better engagement
- One or two simple and attractive communications and marketing resources about FSM can make a difference



Next Steps

- An impact report is being written up. It will be shared shortly with project partners and all schools
- Schools are encouraged to consider how they can use learning from the project to support FSM engagement within their school community
- Other partners in the project will continue to implement and embed the proposals for their services and organisations
