

Road Traffic Acts

THE LONDON BOROUGH OF BARKING AND DAGENHAM (VARIOUS ROADS) (20MPH SPEED LIMIT) ORDER 2023

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barking and Dagenham in exercise of its powers under sections 84, 124 and Parts I to IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended (hereinafter called “the Act”) and all other enabling legislation and powers and after consultation with the Commissioner of Police of the Metropolis in accordance with Part IV of Schedule 9 of the Act made the above Order, the effect of which will be to:

1. Introduce a 20mph Speed Limit at the following locations:
 - a. Dawson Avenue, both sides, from its junction with Lambourne Road to its junction with Upney Lane.
 - b. Dawson Gardens, both sides, from its junction with Dawson Avenue for its entire length.
 - c. North Street, both sides, from its junction with London Road to its junction with Broadway.
 - d. Broadway, both sides, from its junction with North Street to its junction with St Pauls Road.
 - e. St Pauls Road, both sides, from its junction with Abbey Road to its junction with Broadway.
 - f. Becontree Avenue, both sides, from its junction with Motts Lane to its junction with Walnut Tree Road.
 - g. Becontree Avenue, both sides, from its junction with Bennetts Castle Lane to its junction with Longbridge Road.
 - h. School Way, both sides, from its junction with Becontree Avenue for its entire length.
 - i. Connor Road, both sides, from its junction with Northfield Road to its junction with St Georges Road.
 - j. Joyners Close, both sides, from its junction with Connor Road for its entire length.
 - k. St Georges Road, both sides, from its junction with Connor Road to its junction with Beverley Road.
 - l. Beverley Road, both sides, from its junction with Maxey Road to its junction with Northfield Road.
 - m. Western Avenue, both sides, from its junction with Rainham Road South for its entire length.
 - n. Saville Road, both sides, from its junction with High Road for its entire length.

A copy of the Orders, which will come into force on 20 July 2023 and the Council’s Statement of Reasons for making the Orders are available to view for a period of 6 weeks from the date on which this notice is published on the Councils website by visiting the following webpage

Any person wishing to question the validity of the Order or of any of its provisions on the grounds that they are not within the powers of the Act, or that any requirement of the Act or any Regulations under it have not been complied with may do so within six weeks of the made date of the Order by applying to the High Court.
