THE LONDON BOROUGH OF BARKING AND DAGENHAM (LOADING PLACES, PARKING PLACES AND WAITING RESTRICTIONS) (DAGENHAM ROAD) AMENDMENT No. 107 ORDER 2023

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barking and Dagenham in exercise of its powers under sections 6, 124 and Parts I to IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended (hereinafter called "the Act") and all other enabling legislation and powers and after consultation with the Commissioner of Police of the Metropolis in accordance with Part IV of Schedule 9 of the Act made the above Order, the effect of which will be to:

- 1. Introduce No Waiting at any time restrictions on Dagenham Road at the following locations:
 - a. West side, from a point 2 metres north of a point opposite the common boundary of Nos. 213/215 Dagenham Road for 3 metres in a southerly direction.
 - b. West side, from a point 1 metre north of the common boundary of Nos. 312/314 Dagenham Road for 12 metres in a northerly direction.
 - c. West side, from the southern boundary of No. 322 Dagenham Road for 15 metres in a southerly direction.
 - d. South-east side, from a point 12 metres south-west of its junction with Felhurst Crescent for 8 metres in a south-westerly direction.
 - e. South-east side, from a point 34.5 metres north-east of its junction with Felhurst Crescent to a point 11.5 metres north-east of a point opposite the north-eastern property boundary of No. 808 Dagenham Road.
 - f. South-east side, from a point 4.5 metres north-east of the eastern property boundary of No. 790 Dagenham Road for 14 meters in a north-easterly direction.
 - g. North side, from a point 19.5 metres east of its junction with Park Drive for 5 metres in an easterly direction.
- 2. Introduce No Waiting Mon-Fri 8.30am-5.30pm restrictions on Dagenham Road at the following locations:
 - a. West side, from a point 1.5 metres south of a point opposite the common boundary of Nos. 169/171 Dagenham Road for 34.5 metres in a southerly direction.
 - b. West side, from a point 2 metres south of the northern property boundary of No. 217a Dagenham Road for 20.5 metres in a southerly direction.
 - c. West side, from a point opposite the common boundary of Nos. 233/235 Dagenham Road for 80.5 metres in a southerly direction.
 - d. West side, from a point 1 metre north of the common boundary of Nos. 312/314 Dagenham Road for 7 metres in a southerly direction.
 - e. West side, from the southern boundary of No. 322 Dagenham Road for 3 metres in a northerly direction.
 - f. East side, from a point 3 metres south of the common boundary of Nos. 165/167 Dagenham Road for 53 metres in a southerly direction.
 - g. East side, from a point 2 metres north of the common boundary of Nos. 213/215 Dagenham Road for 34.5 metres in a southerly direction.
 - h. East side, from the common boundary of Nos 223/225 Dagenham Road for 91 metres in a southerly direction.
 - i. East side, from a point 9.5 metres south of its junction with Lincoln Avenue for 38.5 metres in a southerly direction.
 - j. South-east side, from a point 5 metres north-east of its junction with Felhurst Crescent for 29.5 metres in a north-easterly direction.
 - k. South-east side, from a point 18.5 metres north-east of the eastern property boundary of No. 790 Dagenham Road for 81.5 meters in a north-easterly direction.
 - I. South-east side, from a point 6 metres north-east of its junction with Eastbrook Avenue for 111 metres in an easterly direction
 - m. South side, from a point 32 metres west of its junction with Park Drive for 176.5 metres in an easterly direction.
 - n. North-west side, from a point 2 metres south-west of the common boundary of Nos. 832/834 Dagenham Road for 58 metres in a north-easterly direction.
 - o. North-west side, from the common boundary of Nos. 812/814 Dagenham Road for 4 metres in a north-easterly direction.
 - p. North-west side, from a point 2.5 metres south-west of the north-eastern property boundary of No. 808 Dagenham Road for 5.5 metres in a north-easterly direction.
 - q. North-west side, from a point 21 metres north-east of the north-eastern property boundary of No. 808 Dagenham Road for 4 metres in a north-easterly direction.
 - r. North-west side, from a point 12 metres south-west of its junction with Central Park Avenue for 16 metres in a south-westerly direction.
 - s. North-west side, from a point 13.5 metres east of its junction with Central Park Avenue to a point 11.5 metres west of its junction with Park Drive.
 - t. North side, from the western property boundary of No. 706 Dagenham Road for 94 metres in an easterly direction.
- 3. Introduce unrestricted 4 wheel parking on the footway on Dagenham Road at the following locations:
 - a. West side, from a point 1.5 metres south of a point opposite the common boundary of Nos. 169/171 Dagenham Road for 30 metres in a southerly direction.
 - b. West side, from a point 10 metres south of the northern property boundary of No. 217a Dagenham Road for 12.5 metres in a southerly direction.
 - c. West side, from a point 6 metres south of the common boundary of Nos. 300/302 Dagenham Road for 15 metres in a southerly direction.
 - d. East side, from a point 2.5 metres south of the common boundary of Nos. 169/171 Dagenham Road for 7 metres in a southerly direction.
 - e. East side, outside No. 175 Dagenham Road.
 - f. East side, from the common boundary of Nos. 215/217 Dagenham Road for 16 metres in a northerly direction.

- g. East side, from a point 2 metres south of the northern property boundary of No. 217a Dagenham Road for 7 metres in a southerly direction.
- h. East side, from the southern property boundary of No. 225 Dagenham Road for 11 metres in a southerly direction.
- East side, from the common boundary of Nos. 233/235 Dagenham Road for 6.5 metres in a northerly direction.
- j. East side, outside No. 241 Dagenham Road.
- k. East side, from a point 9.5 metres south of its junction with Lincoln Avenue for 11.5 metres in a southerly direction.
- I. East side, from a point 2.5 metres south of the common boundary of Nos. 251/253 Dagenham Road for 8.5 metres in a southerly direction.
- m. East side, from a point 1 metre south of the common boundary of Nos. 255/257 Dagenham Road for 7.5 metres in a southerly direction.
- North-west side, from a point 5.5 metres north-east of the common boundary of Nos. 832/834 Dagenham Road for 6.5 metres in a north-easterly direction.
- o. North-west side, from a point 3.5 metres north-east of the common boundary of Nos. 824/826 Dagenham Road for 9.5 metres in a north-easterly direction.
- p. North-west side, from a point 4 metres north-east of the common boundary of Nos. 820/822 Dagenham Road for 7 metres in a north-easterly direction.
- q. North-west side, from the common boundary of Nos. 780/782 Dagenham Road for 5.6 metres in a north-easterly direction.
- r. North-west side, from the common boundary of Nos. 778/780 Dagenham Road for 13.7 metres in a north-easterly direction.
- s. North-west side, from a point 4.5 metres north-east of the common boundary of Nos. 774/776 Dagenham Road for 10.3 metres in a north-easterly direction.
- t. North-west side, from a point 4.2 metres north-east of the common boundary of Nos. 770/772 Dagenham Road for 7.2 metres in a north-easterly direction.
- u. North-west side, from a point 4.3 metres north-east of the common boundary of Nos. 766/768 Dagenham Road for 9.2 metres in a north-easterly direction.
- v. North side, from a point 27 metres west of its junction with Park Drive for 25.5 metres in a westerly direction.
- w. North side, from a point 56.6 metres west of its junction with Park Drive for 12.3 metres in a westerly direction.
- x. North side, from a point 46.2 metres east of its junction with Park Drive for 12.5 metres in a easterly direction.
- y. North side, from a point 68.2 metres east of its junction with Park Drive for 12.8 metres in a easterly direction.
- z. North side, from a point 3 metres west of the common boundary of Nos. 696/698 Dagenham Road for 9.2 metres in an easterly direction.
- aa. North side, from a point 4.3 metres west of the common boundary of Nos. 692/694 Dagenham Road for 7.9 metres in an easterly direction.
- bb. North side, from a point 8 metres east of the common boundary of Nos. 692/694 Dagenham Road for 14.8 metres in an easterly direction.
- cc. South-east side, from a point 12 metres north-east of its junction with Felhurst Crescent for 6.5 metres in a north-easterly direction.
- dd. South-east side, from the common boundary of Nos. 813/815 Dagenham Road for 7.7 metres in a north-easterly direction.
- ee. South-east side, from a point 6.7 metres south-west of its junction with Eastbrook Avenue for 6.1 metres in a south-westerly direction.
- ff. South-east side, from a point 13.5 metres south-west of its junction with Eastbrook Avenue for 15 metres in a south-westerly direction.
- gg. South-east side, from a point 6.5 metres south-west of the common boundary of Nos. 799/801 Dagenham Road for 10.7 metres in a north-easterly direction.
- 4. Introduce unrestricted parking bays on the carriageway on Dagenham Road at the following locations:
 - a. West side, from a point 6 metres south of the common boundary of Nos. 312/314 Dagenham Road for 37 metres in a southerly direction.
 - b. North-west side, from a point 2.5 metres north-east of the common boundary of Nos. 816/818 Dagenham Road for 5.5 metres in a north-easterly direction.
 - c. North-west side, from a point 4 metres north-east of the common boundary of Nos. 812/814 Dagenham Road for 15 metres in a north-easterly direction.
 - d. North-west side, from a point 3 metres north-east of the north-eastern property boundary of No. 808 Dagenham Road for 18 metres in a north-easterly direction.
- 5. Introduce a Goods Vehicle loading only 30mins no return within 1hour Bay on Dagenham Road, north-west side, outside No. 814 Dagenham Road.
- 6. Revoke the Disabled Blue badge holders only bay on Dagenham Road, north-west side, outside No. 824 Dagenham Road.

Any person wishing to question the validity of the Order or of any of its provisions on the grounds that they are not within the powers of the Act, or that any requirement of the Act or any Regulations under it have not been complied with may do so within six weeks of the made date of the Order by applying to the High Court.
