THE LONDON BOROUGH OF BARKING AND DAGENHAM (OFF-STREET PARKING PLACES) (CONTROLLED PARKING ZONE CH EXTENSION S16) (AMENDMENT NO. 32) ORDER 2023

The Council of the London Borough of Barking and Dagenham in exercise of their powers under Sections 6, 32, 33, 35 and 124 and Parts I to IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") as amended by the relevant provisions of the Local Government Act 1985 the Parking Act 1989 and all other enabling and amending legislation and enabling powers, and after consultation with the Commissioner of Police of the Metropolis in accordance with Part IV of Schedule 9 of the Act, hereby make the following Order:

- This Order shall come into operation on 6 November 2023 and may be cited as The London Borough of Barking and Dagenham (Off-Street Parking Places) (Controlled Parking Zone Ch Extension S16) (Amendment No. 32) Order 2023.
- 2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order.
- 4. In this Order, the "Principle Order" shall mean The London Borough of Barking and Dagenham (Off-Street Parking Places) Order 2017.
- 5. The items shown as No. 1/58 and 1/59 in columns 1 to 12 of Schedule 1 to this Order shall be appended to Schedule 1 of the Principle Order.
- 6. The item shown as No. 1/24 in columns 1 to 12 of Schedule 1 to this Order shall replace item 1/24 of the Principle Order.
- 7. The items shown in Schedule 2 and the plans attached to this Order shall be added to the items in Schedule 3 and the plans attached to the Principle Order.
- 8. Item No. 1/24 shown in Schedule 3 and the plans attached to this Order shall replace item No. 1/24 in Schedule 3 and the plans attached to the Principle Order.
- 9. The following Article 6 (11) (d) shall be revoked from the Principle Order;

(d) vehicles left wholly within the Earls Walk Housing Car Park, Earls Walk, Dagenham.

10. The charges applicable to Chadwell Heath Controlled Parking Zone CH permits is as set out in the Principle Order Schedule 4, subject to any subsequent changes by Notice of Variation. The Permit Charges shown in Schedule 4 to this Order sets out the Principle Order Schedule 4 charges applicable to Permit CH permits on the date this Order comes into effect. Dated this 18 day of

(6) An additional charge of £0.60 will be applied to all of Item 1/3 Up to 4 hours parking payments for diesel vehicles that do not meet Euro 6d emission standards with effect from 1st February 2021.

(7) An additional charge of £7.00 will be applied to all of Items 1/2 and 1/3 1 month Season ticket parking payments for diesel vehicles that do not meet Euro 6d emission standards with effect from 1st February 2021.

(8) An additional charge of £19.00 will be applied to all of Items 1/3 3 month Season ticket parking payments for diesel vehicles that do not meet Euro 6d emission standards with effect from 1st February 2021.

(9) An additional charge of £38.00 will be applied to all of Items 1/3 6 month Season ticket parking payments for diesel vehicles that do not meet Euro 6d emission standards with effect from 1st February 2021.

(10) An additional charge of £75.00 will be applied to all of Items 1/2 and 1/3 12 month Season ticket parking payments for diesel vehicles that do not meet Euro 6d emission standards with effect from 1st February 2021.

(15) An additional charge of £75 will be applied to all of Items 1/2 6 month Season ticket parking payments for diesel vehicles that do not meet Euro 6d emission standards with effect from 1st February 2022.
