**TRAFFIC MANAGEMENT ORDER**

**THE LONDON BOROUGH OF BARKING AND DAGENHAM (ORANGE PERMIT PARKING) (STANSGATE ROAD) AMENDMENT No. 117 ORDER 2023**

The Council of the London Borough of Barking and Dagenham in exercise of their powers under Sections 6, 45, 46, 49 and 124 and Parts I to IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called “the Act”) and of all other enabling and amending legislation and powers and after consultation with the Commissioner of Police of the Metropolis in accordance with Part IV of Schedule 9 of the Act, hereby make the following Order:

1. This Order shall come into operation on 20 November 2023 and may be cited as The London Borough of Barking and Dagenham (Orange Permit Parking) (Stansgate Road) Amendment No. 117 Order 2023.
2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Barking and Dagenham (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) Consolidation Order 2016 “the Free Parking Places Order” and the London Borough of Barking and Dagenham (Charged-For Parking Places) Consolidation Order 2016 “the Charged-For Order” shall have effect as though:

Schedule 2 is amended by the replacement of the following Map Tiles:

S14 revision 3 replaced by S14 revision 4

4. The Charged-For Order is amended by inserting in to Schedule 3 the row for Permit identifier Orange as shown in Schedule 1 to this Order.
5. The Charged-For Order is amended by inserting in to Schedule 5 the table for Permit identifier Orange as shown in Schedule 2 to this Order.
6. Schedule 4 of the Charged-For Order is amended by the insertion of Schedule 3 to this Order, subject to any subsequent changes by Order or Notice of Variation.
7. The Permits listed as valid for parking places will be amended by the substitution of Schedule 4 to this Order for Schedule 6 of the Charged-For Order.

(2) Only applicable in Off-Street Car Parks where use of Residents' Permits is permitted.

(3) An additional charge of £75 will be applied to all resident and business parking permits for diesel vehicles that do not meet Euro 6d emission standards with effect from 1<sup>st</sup> April 2019.

(4) Any additional vehicle resident permits in excess of 2 vehicles are subject to a minimum charge of £45.

(5) An additional charge of £75 will be applied to all Business / Trade (Annual) and Operational Permit - Annual parking permits for diesel vehicles that do not meet Euro 6d emission standards with effect from 1<sup>st</sup> February 2021.

(6) An additional charge of £1 will be applied to all Parking Waiver – Daily parking permits for diesel vehicles that do not meet Euro 6d emission standards with effect from 1<sup>st</sup> February 2021.

(7) An additional charge of £2 will be applied to all Parking Waiver - Weekly parking permits for diesel vehicles that do not meet Euro 6d emission standards with effect from 1<sup>st</sup> February 2021.

- (8) An additional charge of £5 will be applied to all Temporary parking permits for diesel vehicles that do not meet Euro 6d emission standards with effect from 1<sup>st</sup> February 2021.
- (9) An additional charge of £7 will be applied to all Staff Permits - Standard (Monthly) parking permits for diesel vehicles that do not meet Euro 6d emission standards with effect from 1st February 2022.
- (10) An additional charge of £75 will be applied to all Staff Permits - Red (Annual) parking permits for diesel vehicles that do not meet Euro 6d emission standards with effect from 1st February 2021.
- (11) Tariff Band 1 refers to Emissions (CO<sub>2</sub>) g/km 0-50, Band 2 refers to Emissions (CO<sub>2</sub>) g/km 51-100, Band 3 refers to Emissions (CO<sub>2</sub>) g/km 101-140, Band 4 refers to Emissions (CO<sub>2</sub>) g/km 141-160, Band 5 refers to Emissions (CO<sub>2</sub>) g/km 161-180, Band 6 refers to Emissions (CO<sub>2</sub>) g/km 181-255, Band 7 refers to Emissions (CO<sub>2</sub>) g/km Over 256.
- (12) An additional charge of £0.50 will be applied to all Staff Permits - Standard (4 Hours), Staff Permits - Standard (Daily), Business / Trade (Daily), Business / Trade (4 Hour), Healthcare Permit - Daily, Healthcare Permit - 4 Hour, Operational Permit – Daily and Operational Permit – 4 Hour parking permits for diesel vehicles that do not meet Euro 6d emission standards with effect from 1st February 2022.
- (13) An additional charge of £75 will be applied to all Healthcare Permit - Annual and Staff Permits – Standard (Annual) parking permits for diesel vehicles that do not meet Euro 6d emission standards with effect from 1st February 2022.
- (14) An additional surcharge of £75 surcharge will be applied to all Car Club Permits for diesel vehicles.
