THE LONDON BOROUGH OF BARKING AND DAGENHAM (PAYMENT PARKING RESTRICTIONS) (GALE STREET) AMENDMENT No. 119 ORDER 2023

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barking and Dagenham in exercise of its powers under sections 6, 124 and Parts I to IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended (hereinafter called "the Act") and all other enabling legislation and powers and after consultation with the Commissioner of Police of the Metropolis in accordance with Part IV of Schedule 9 of the Act made the above Order, the effect of which will be to:

1. Revoke part of the existing Payment Parking (TC2) Mon-Fri 8.30am-5.30pm Max stay 4hrs No return within 2hrs restrictions at the following locations:
 - a. Gale Street, west side, from a point 114.5 metres north of its junction with Ripple Road for 7.4 metres in a northerly direction.
 - b. Gale Street, east side, from a point 114.5 metres north of its junction with Ripple Road for 12 metres in a northerly direction.

Barking and Dagenham hereby GIVES FURTHER NOTICE in exercise of the powers conferred by Section 90A-F of the Highways Act 1980 as amended and of all other enabling powers and in accordance with the Highways (Road Humps) Regulations 1999 as amended and after consultation with the Commissioner of Police of the Metropolis intends to construct the following traffic calming measures;

2. A 75mm high speed cushion with a 1:8 on/off gradient, 1.7m wide and 2m in length on Gale Street, at a point 80.5 metres south of its junction with Goresbrook Road.
3. A 75mm high raised table with a 1:15 on/off gradient, across the entire carriageway width and 7.4m in length on Gale Street, at a point 118 metres north of its junction with Ripple Road.
4. A 75mm high speed cushion with a 1:8 on/off gradient, 1.7m wide and 2m in length on Gale Street, at a point 61 metres north of its junction with Ripple Road.

A copy of the Orders, which will come into force on 11 December 2023 and the Council's Statement of Reasons for making the Orders are available to view for a period of 6 weeks from the date on which this notice is published on the Council's website by visiting the following webpage <https://www.lbbd.gov.uk/parking/parking-area> and selecting 'New and proposed traffic and parking schemes' or available for inspection at the Adult Library, First Floor, Barking Learning Centre, Barking between the hours of 9.00am and 4.00pm Monday to Friday.

Any person wishing to question the validity of the Order or of any of its provisions on the grounds that they are not within the powers of the Act, or that any requirement of the Act or any Regulations under it have not been complied with may do so within six weeks of the made date of the Order by applying to the High Court.
