(PERMIT PARKING AND WAITING RESTRICTIONS)  
(AREA 3 CONTROLLED PARKING ZONE CH1)  
AMENDMENT NO. 150 ORDER 2025**

The Council of the London Borough of Barking and Dagenham in exercise of their powers under Sections 6, 45, 46, 49 and 124 and Parts I to IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") as amended and all other and amending legislation and enabling powers, and after consultation with the Commissioner of Police of the Metropolis in accordance with Part IV of Schedule 9 of the Act, hereby make the following Order:

1. This Order shall come into operation on 4<sup>th</sup> August 2025 and may be cited as The London Borough of Barking and Dagenham (Permit Parking and Waiting Restrictions) (Area 3 Controlled Parking Zone CH1) Amendment No. 150 Order 2025.
2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Barking and Dagenham (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) Consolidation Order 2016 "the Free Parking Places Order" and the London Borough of Barking and Dagenham (Charged-For Parking Places) Consolidation Order 2016 "the Charged-For Order" shall have effect as though:

6. The charges applicable to the Chadwell Heath 1 Controlled Parking Zone CH1 permits and pay by phone bays are as set out in the Charged-For Order Schedules 4 and 7, subject to any subsequent changes by Order or Notice of Variation. Schedule 3 to this Order sets out these charges as applicable to the Controlled Parking Zone CH1 area on the date this Order comes into effect.
