What is the Purpose of the Ending Rough Sleeping Plan?

As we enter the third year of the RSI 2022-25 programme, we are asking local authorities to reflect on their progress towards ending rough sleeping. This form provides an opportunity to review your progress and identify your area's top priorities for the upcoming year of RSI delivery. The plan:

- Provides an opportunity for local authorities to consider your delivery priorities and identify the key actions for 2024/25 to enable you to have the greatest
 impact in reducing the number of individuals sleeping rough in your area. We recommend that your Ending Rough Sleeping Plans should complement and
 reflect what you have set out in your local area's current Homeless Prevention and Ending Rough Sleeping Strategy, as published on your local authority's
 website.
- Is intended to be a live document, that you can use regularly throughout the year (and at least quarterly) to review progress against your planned delivery with your DLUHC Rough Sleeping adviser.
- Is a grant condition of your Rough Sleeping Initiative 2022-25 funding, as found in Annex D of the Programme management overview and payment schedule. This was first sent to you in May 2022, and is also included in your grant determination letter on receipt of all RSI payments.
- In addition to supporting your work locally, completion of the plan helps DLUHC to better understand and hold record of the challenges and successes of delivery to end rough sleeping in your local area.

What is in the Ending Rough Sleeping Plan?

To reduce the administrative burden on local areas as much as possible, we have streamlined the Ending Rough Sleeping plan structure for 2024/25, to contain only the priority information required and removing any duplication with existing reporting already provided by local areas on Delta.

Within the Ending Rough Sleeping Plan 2024/25, we ask you to:

- 1. Review the individuals currently within your Target Priority Group / T1000 and provide an update on the number in this group for 2024/25
- 2. Review the number of beds and staff you will be delivering through RSI funding in 2024/25.
- 3. Consider what has worked well in the last 12 months of the programme (2023/24).
- 4. Consider what are the biggest challenges you will face over the next 12 months (2024/25) and what actions you can take during the year to address these challenges and deliver a reduction in rough sleeping.
- 5. Provide information on how you are progressing on embedding long-term services into wider funding streams in your area, in preparation for the end of the RSI 2022-25 funding period.

Outreach officer has good partnerships with statutory and voluntary agencies and knows rough sleepers and engages quickly with focus on resolution of rough sleeping

Immigration Advice, support and escalation

Establishing mechanisms for greater co-operation between North East London councils allows us to work more effectively together. Escalation routes with the Home Office are also working well to get issues resolved as quickly as possible

Bed management meeting twice weekly with NHS. These help provide earlier intervention and relief of client homelessness on discharge from hospital, enabling better planning for these customers

Being provided by a CVS organisation has meant that support continues to be offered on a wide range of issues, including housing advice, benefits and pensions, work and employment, health and drugs and alcohol support. People can receive this support without having to prove their level of need or eligibility, so through this service we can identify and help those who might be at risk of rough sleeping. This offer is linked to our warm spaces and community food clubs, which provides further opportunities for identification of need and opportunities for support.
