# Introduction

## About this document

Barking and Dagenham is one of London’s biggest growth and regeneration opportunities with more than 400 hectares of developable land, including some of the Capital’s largest stretches of undeveloped riverside frontage.

Successive London Plans have identified the regeneration potential across the Borough, given its excellent transport links, affordability and location of part of the Borough within the London Riverside Opportunity Area and the Thames Estuary Corridor.

Additionally, four of London’s fifteen key industrial sites identified in the Growth Plan are located within the Borough, including UCL Pearl, Thames Freeport, the London Sustainable Industries Park, and Box Lane and Thames Road. This highlights the enormous potential for growth in jobs and innovative employment land.

Continued investment in infrastructure is critical to unlocking growth in Barking and Dagenham. Investment in transport, utilities, digital connectivity, flood defences, and social infrastructure underpins the Borough’s ability to accommodate new homes and jobs sustainably. Infrastructure investment in catalytic infrastructure projects such as the extension of the London Overground to Barking Riverside are key to unlocking this growth potential. Continued financial commitment from both

public and private sectors, and co-funding through developer contributions, is essential to realising the scale of growth in the Borough.

This Infrastructure Funding Statement (IFS) provides our annual report on developer contributions received and allocated by the London Borough of Barking and Dagenham to address the impact of development on the borough, as required by the CIL Regulations (2010).

### This IFS sets out:

- The projects or types of infrastructure which the charging authority intends will be, or may be, wholly or partly funded by the CIL;
- a report on CIL including receipts, allocations to projects and expenditure; and
- a report on s106 including receipts, allocations to projects and expenditure.





# Explaining developer contributions

There are two key types of developer contributions that are used to fund infrastructure, the Community Infrastructure Levy (CIL) and Section 106 (S106) planning obligations. These are set out in our adopted Planning Obligations SPD (2024).

CIL is a charge which can be levied by local authorities on new development in their area. It is an important tool for local authorities to help deliver the infrastructure needed to support development. Most new development which creates net additional floor space of 100 square metres or more, or creates a new dwelling, is potentially liable for the levy. LBBB charges CIL on development in the borough, as set out in the Charging Schedule (2015)<sup>1</sup>. This document will be reviewed within the next year.

In our authority area, 80% of CIL is to be used for the funding of strategic infrastructure projects (referred to as Strategic CIL (SCIL), and 15% must be spent on neighbourhood projects, determined in consultation with communities (referred to as Neighbourhood CIL (NCIL). NCIL can be spent on infrastructure to support development and more widely on addressing the local demands that development places on the area. The remaining 5% is retained by Council as an administrative fee.

S106 planning obligations are ‘secured’ through legal

agreements known as Section 106 agreements under section 106 of the Town and Country Planning Act 1990 or unilateral undertakings. They are negotiated between the Council and developers and can be used to secure local plan policies – such as making sure affordable housing is delivered on site – and to mitigate specific development impacts.

Council’s Planning Obligations Supplementary Planning Document (SPD) published in 2024, provides contemporary guidance on S106 contributions in the borough to planning officers, developers and the community.

The use of S106 is governed by legal tests set out in the Community Infrastructure Levy Regulations (2010) as amended. These tests require that any s106 asks are:

- necessary to make the development acceptable in planning terms;
- directly related to the development; and
- fairly and reasonably related in scale and kind to the

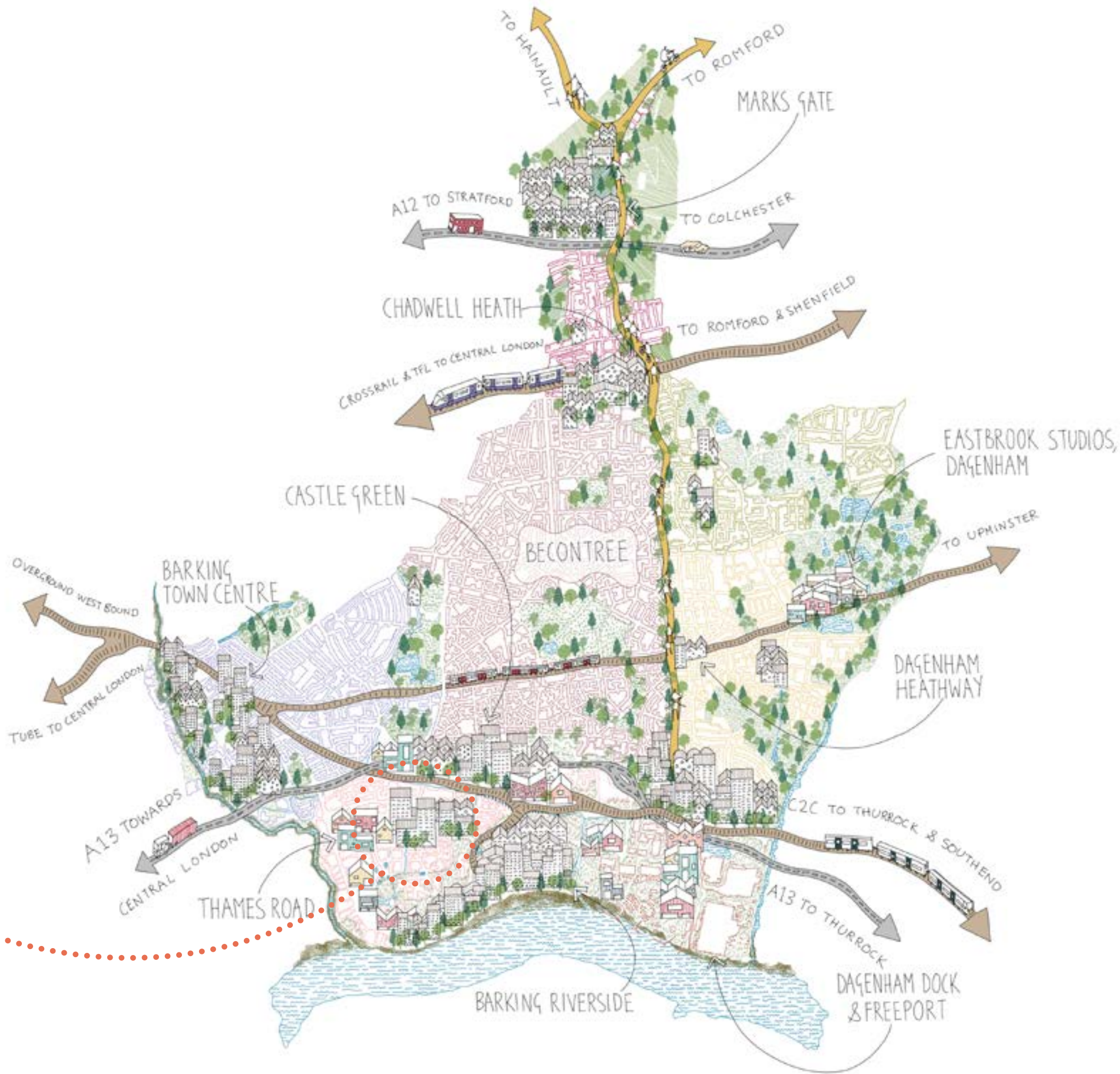
# Local Plan

## Overview

The Local Plan 2037, adopted in September 2024, sets out the anticipated levels of growth across the borough until 2037, and this is supported by the Council’s Infrastructure Delivery Plan (IDP).

The IDP sets out the current provision of infrastructure and provides an overview of future infrastructure needs to support growth in the borough, reflecting the growth set out in the Plan. The IDP also provides guidance to planning officers and developers in understanding capacity for growth, and where contributions to new infrastructure may be required.

The Council is currently refreshing the IDP and is expecting to publish an updated version in mid 2026.





# Prioritising infrastructure spend

Chapter 3 of the Local Plan 2037 sets out the proposed distribution for growth and important priorities for infrastructure delivery across these areas and Appendix 2: Site Allocations sets out specific details around land allocated for future development.

The main growth areas identified in our Local Plan are concentrated in ‘Transformation Areas’. These are:

- Barking Town Centre and the River Roding
- Barking Riverside
- Thames Road
- Castle Green
- Chadwell Heath
- Marks Gate
- Dagenham Dock and Freeport
- Beam Park
- Dagenham East
- Dagenham Heathway

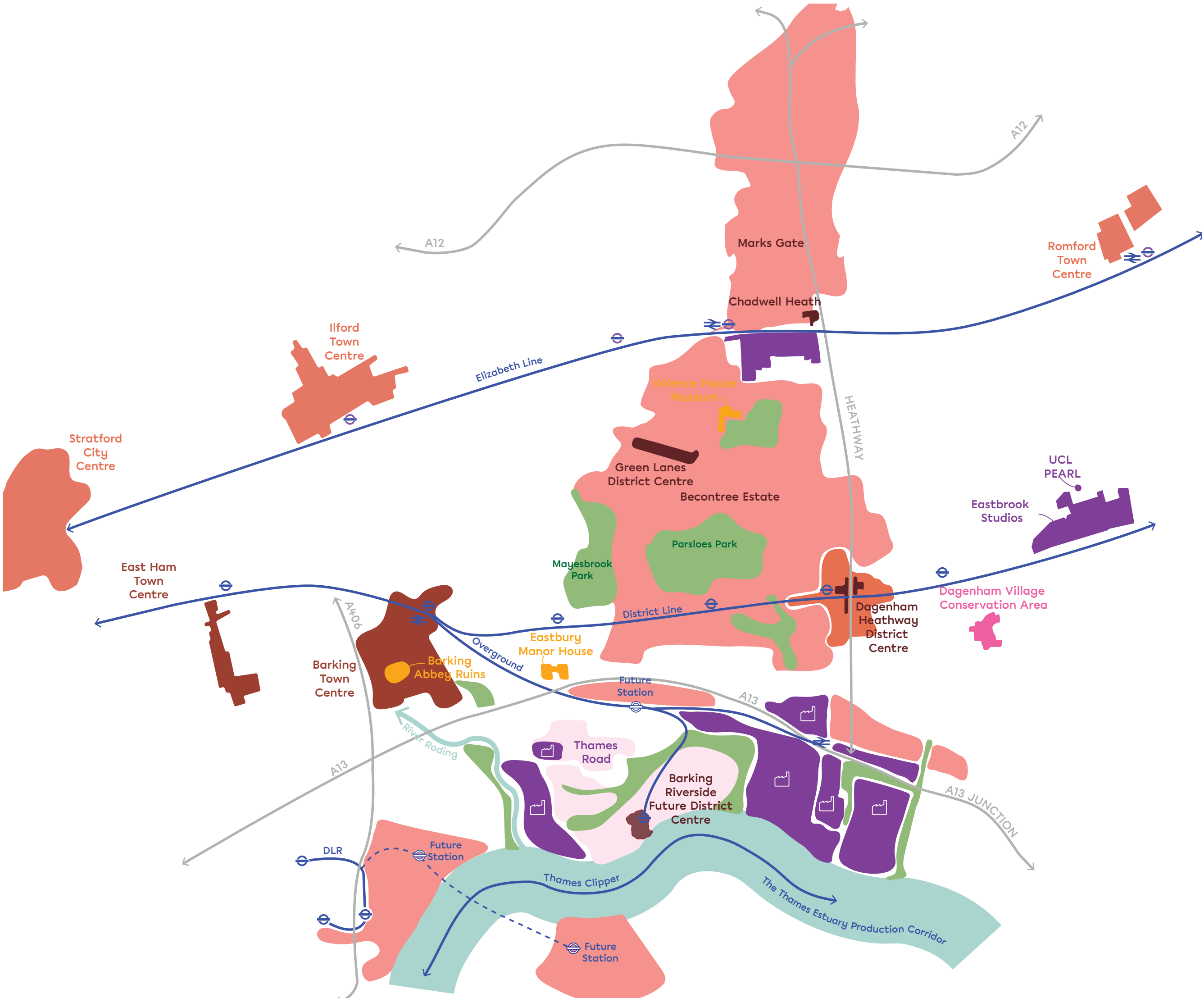
CIL funding will be used alongside Section 106 developer contributions, capital funding, and other public sources of funding to support new infrastructure and improve the quality and capacity of existing infrastructure, to provide for our communities and support further growth and investment. The Local Plan 2037 sets out the intention to unlock growth and regeneration through infrastructure investment, and while it cannot be the only funding source for large projects, S106 contributions and CIL funding is a key element of realising this ambition and leveraging the opportunity presented by our

## Transformation Areas.

The Council may use CIL to fund the following types of infrastructure:

- Education facilities
- Transport improvements
- Environmental improvements including hard and soft landscaping, green grid and blue ribbon
- Sport, leisure, parks and open spaces
- Health facilities
- Business support facilities
- Community safety projects
- Community facilities
- Flood defences

The Council intends to fund the CIL projects identified in Section 3. Funding has been formally allocated to these projects, by decision of Council, or Cabinet where appropriate.





# Allocating developer contributions

Decisions related to the allocation and expenditure of SCIL will be the subject to the decision of Council, and Cabinet where the project is valued at more than £200,000.

Decisions on the allocation and expenditure NCIL will continue to be determined in consultation with communities across the borough with allocations generally occurring every six months. More information on NCIL is set out on our website<sup>2</sup>.

The expenditure of all S106 contributions will be in line with the requirements on the S106 agreement or Unilateral Undertaking in which they are secured and details of spend and allocation of S106 is provided.

# CIL Refund

In 2023, £1,568,705.30 was paid in CIL for two approved phases of the Gascoigne Estate, Gascoigne East Phase 3a and 3b. At this time, both schemes included private housing, and the CIL relief for social housing was calculated accordingly under Regulation 49 of the CIL Regulations 2010.

The provision of affordable housing for both phases has subsequently been revised so that both phases are now providing 100% affordable housing. As a result, the schemes were eligible for further social housing relief, reducing the CIL liability. Accordingly, a refund of £1,568,705.30 was repaid from Borough CIL in 2024/25.

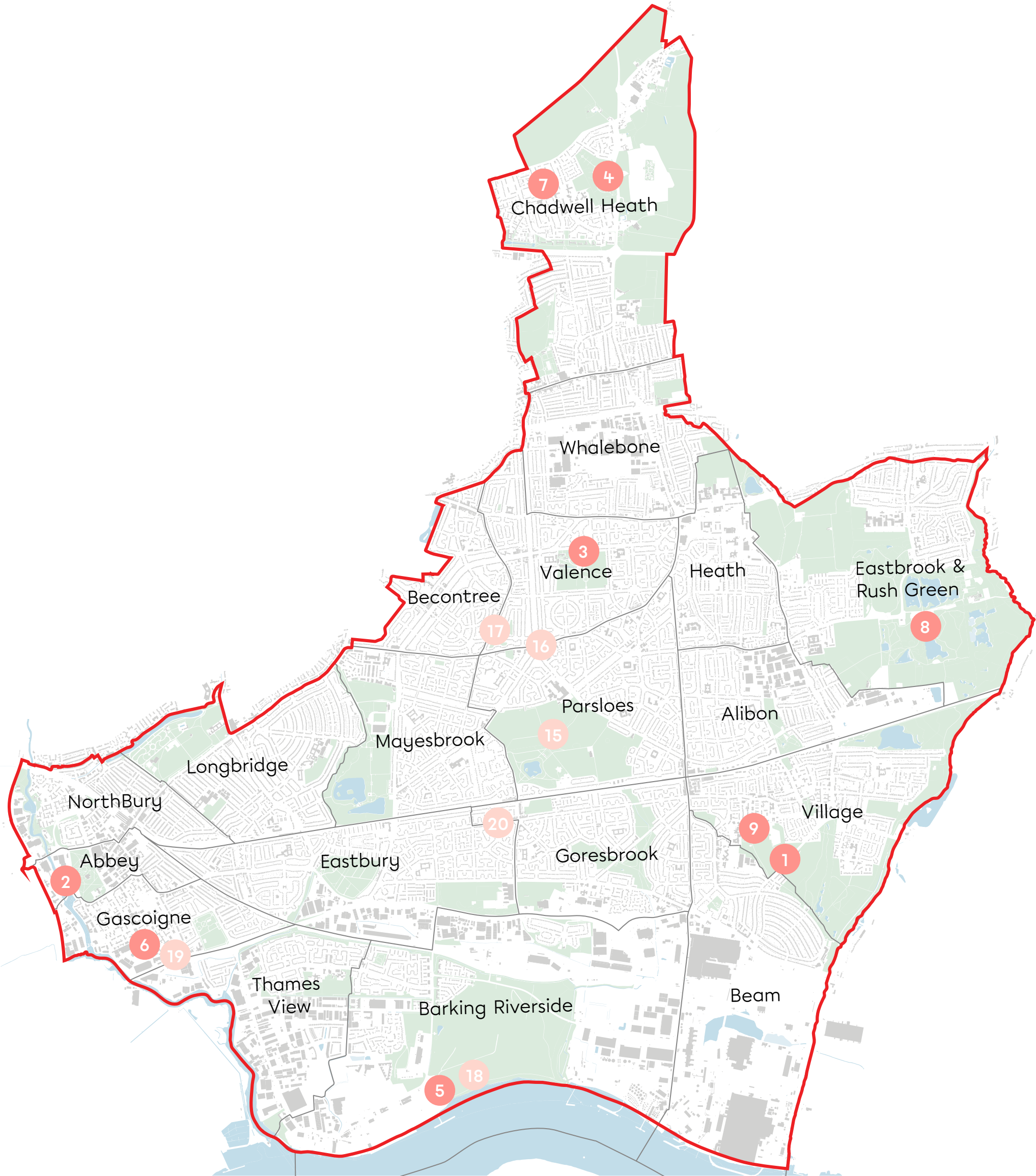

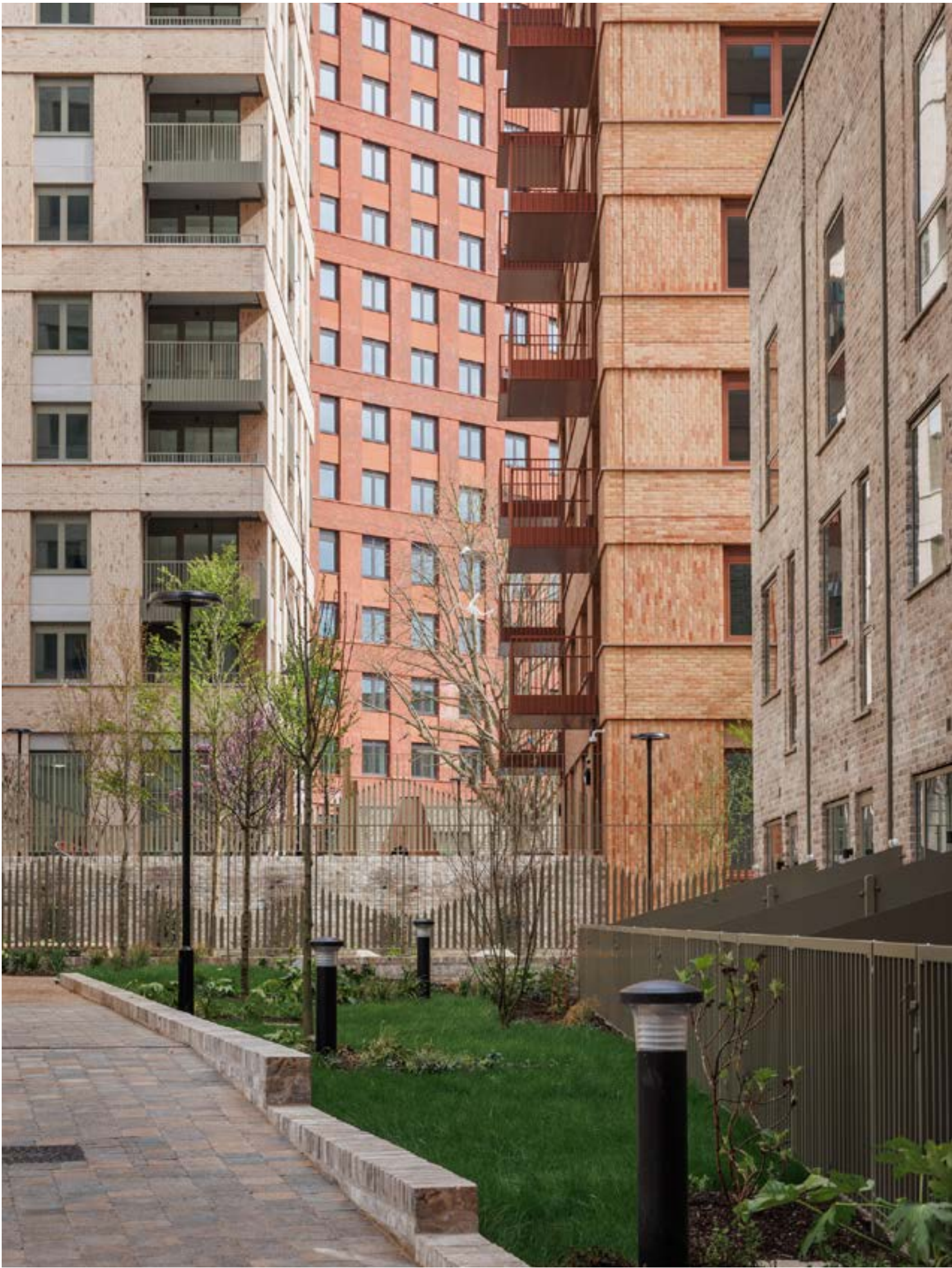

	Urban Promise	The NCIL funding will support Student Leaders in their communities. A Student Leader is a young person (age 14-18) that is a leader and role model for the younger children in their local community that attend our after-school club. The programme is a fully fledged job with Student Leaders receiving a stipend, payslips, and employee reviews. This approach allows us to nurture young people into the world of work.	£10,000
	JD Striving for Excellence	The NCIL grant will further their mission and sustain our 'JDS Business Shower' programme. This ten-month programme is co-designed with 20 young people (YP) between 14 and 25 to assist in their career development. The programme encompasses paid work experience, employability skills, guidance on business plan creation, and an event to showcase their ventures.	£10,000
	Barking Enterprise Centre	BEC CIC has been supporting the social sector in taking over the lease for Heath Park community centre.
