NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barking and Dagenham in exercise of its powers under 6, 32, 33, 35, 45, 46, 49 and 124 and Parts I to IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended (hereinafter called "the Act") and all other enabling legislation and powers and after consultation with the Commissioner of Police of the Metropolis in accordance with Part IV of Schedule 9 of the Act propose to make the above Orders, the effect of which will be to:

ON-STREET AMENDMENTS

1. Introduce a 'Disabled Badge Holders Only' bay at the following locations:
 - a. **Pavet Close**, west side, outside No. 7 Pavet Close for 5 metres, replacing existing 'No waiting Mon-Sat 8.30am-5.30pm' restrictions.
 - b. **Coombewood Drive**, west side, outside No. 28 Coombewood Drive for 6 metres, replacing existing 'Resident Permit Holders Only Zone CH Mon-Fri 8.30am-5.30pm' bay.
 - c. **Valence Avenue**, east side, fully on the road outside No. 497, replacing existing 'Disabled Badge Holders Only' bay fully on the footway and existing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
2. Introduce a 'Resident Permit Holders Only Zone HW2 Mon-Sat 8.30am-5.30pm' bay, the current charges applicable being those set out in this Order, at the following locations:
 - a. **Pavet Close**, west side, outside No. 2-4 Pavet Close for 14.9 metres, replacing existing 'No waiting Mon-Sat 8.30am-5.30pm' restrictions.
 - b. **Pavet Close**, west side, from a point 5.3 metres north of its junction with Blackborne Road for 5.2 metres in a northerly direction, replacing existing 'No waiting Mon-Sat 8.30am-5.30pm' restrictions
3. Introduce 'No waiting Mon-Sat 8.30am-5.30pm' restrictions at the following locations:
 - a. **Pavet Close**, east side, outside No. 17-20 Pavet Close for 32.6 metres, replacing existing 'Resident Permit Holders Only Zone HW2 Mon-Sat 8.30am-5.30pm' bays.
 - b. **Spurling Road**, northwest side, outside No. 42 Spurling Road for 5.5 metres, replacing existing 'Resident Permit Holders Only Zone HW Mon-Sat 8.30am-5.30pm' bays.
 - c. **Ford Road**, south side, outside No. 121 Ford Road for 5.5 metres, replacing existing 'Resident Permit Holders Only Zone HW Mon-Sat 8.30am-5.30pm' bays.
 - d. **Treswell Road**, west side, outside No. 92 Treswell Road for 9 metres, replacing existing 'Resident Permit Holders Only Zone HW Mon-Sat 8.30am-5.30pm' bays.
 - e. **Osborne Square**, east side, outside No. 139 Osborne Square for 4.8 metres, replacing existing 'Resident Permit Holders Only Zone HW Mon-Sat 8.30am-5.30pm' bays.
4. Introduce a 'Resident Permit Holders Only Zone BEC Mon-Fri 8.30am-5.30pm' bay, the current charges applicable being those set out in this Order, at the following locations:
 - a. **Sheppey road**, south side footpath, outside No. 267 Sheppey road, replacing an existing 'Disabled Badge Holders Only' bay.
5. Introduce 'No Waiting at any time' restrictions at the following locations:
 - a. **Shipton Close**, south side, from a point 5.4 metres east of the junction with Bennett's Castle Lane for a distance of 2.3 metres, replacing existing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
 - b. **Grantham Gardens**, west side, opposite Grantham Court Nos. 1-12 Grantham Gardens for 7.8 metres, replacing existing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
 - c. **Grantham Gardens**, east side, from the southern boundary of Nos. 18-20 Grantham Gardens for 3.6 metres in a southerly direction, replacing existing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
 - d. **Grantham Gardens**, east side, outside Nos. 22-24 Grantham Gardens for 4 metres, replacing existing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
 - e. **Grantham Gardens**, east side, outside Nos. 28-32 Grantham Gardens for 4.4 metres, replacing existing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
 - f. **Gordon Road**, north side, outside No. 81 Movers Lane for 6.1 metres, replacing existing 'Resident Permit Holders Only Zone L Mon-Sat 8.30am-9pm' bays.
 - g. **Renwick Road**, west side, from a point 4.5 metres south of Steel Approach in a northerly direction for 200 metres, replacing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
 - h. **Renwick Road**, east side, outside Warehouse 25-27 Renwick Road for 62.5 metres, replacing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
6. Revoke part of the 'Resident Permit Holders Only Zone HW Mon-Sat 8.30am-5.30pm' restrictions at the following locations:
 - a. **Heathway**, west side, outside No. 401 Heathway for 4.4 metres.
 - b. **Rogers Road**, north side, outside No. 137 Rogers Road for 6.8 metres.

- c. **Hunters Hall Road**, east side, outside No. 198 Hunters Hall Road for 5.4 metres.
7. Introduce 'No waiting 8.30am-9pm' restrictions at the following locations:
 - a. **Jackson Road**, west side, outside No. 20 Jackson Close for 7.5 metres, replacing existing 'Resident Permit Holders Only Zone J 8.30am-9pm' bays.
 - b. **Jackson Road**, east side, outside No. 9 Jackson Close for 7.6 metres, replacing existing 'Resident Permit Holders Only Zone J 8.30am-9pm' bays.
8. Introduce 'No waiting Mon-Fri 1.30pm-2.30pm' restrictions at the following locations:
 - a. **Bradfield Drive**, east side, outside No. 124 Bradfield Drive for 7 metres, replacing existing 'Resident Permit Holders Only Zone UP Mon-Fri 1.30am-2.30pm' bays.
9. Introduce a 'Resident Permit Holders Only Zone BM Mon-Fri 8.30am-4pm' bay, the current charges applicable being those set out in this Order, at the following locations:
 - a. **Ridgewell Close**, south side, outside no. 32 for 4.7 metres, replacing existing 'Disabled Badge Holders Only' bay
10. Introduce 'No waiting Mon-Fri 4.30pm-9pm' restrictions at the following locations:
 - a. **Ridgewell Close**, south side, outside no. 31 for 1.8 metres, replacing existing 'Disabled Badge Holders Only' bay
11. Introduce a 'Resident Permit Holders Only Zone CH1 Mon-Fri 8.30am-5.30pm' bay, the current charges applicable being those set out in this Order, at the following locations:
 - a. **Becontree Avenue**, north side, opposite Nos. 374-380 Becontree Avenue for 14.5 metres, replacing existing 'Ambulance parking' bay.
 - b. **Becontree Avenue**, northeast side, outside Nos. 142-148 Becontree Avenue for 18.5 metres, replacing existing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
 - c. **Becontree Avenue**, northeast side, outside Nos. 176-182 Becontree Avenue for 17.5 metres, replacing existing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.

 - d. **Becontree Avenue**, north side, outside No. 479 Becontree Avenue for 5.7 metres.
 - e. **Grafton Road**, northeast side, outside No. 14 and 16 Grafton Road for 11.5 metres.
13. Introduce 'No waiting Mon-Fri 8.30am-5.30pm' restrictions at the following locations:
 - a. **Valence Avenue**, west side, outside No. 396 Valence Avenue for 5.3 metres, replacing existing 'Resident Permit Holders Only Zone CH1 Mon-Fri 8.30am-5.30pm' bays.
 - b. **Wilmington Gardens**, northeast side, outside No. 6 Wilmington Gardens for 6.8 metres, replacing existing 'Resident Permit Holders Only Zone H Mon-Fri 8.30am-5.30pm' bays.
 - c. **Wilmington Gardens**, southwest side, outside No. 7 Wilmington Gardens for 9.9 metres, replacing existing 'Resident Permit Holders Only Zone H Mon-Fri 8.30am-5.30pm' bays.
 - d. **Babington Road**, west side, outside No. 4 Babington Road for 6.6 metres, replacing existing 'Resident Permit Holders Only Zone STR Mon-Fri 8.30am-5.30pm' bays.
 - e. **Easebourne Road**, southwest side, outside No. 19 Easebourne Road for 6.2 metres, replacing existing 'Resident Permit Holders Only Zone SDB Mon-Fri 8.30am-5.30pm' bays.
 - f. **Babington Road**, east side, outside No. 91 Babington Road for 5.6 metres, replacing existing 'Resident Permit Holders Only Zone STR Mon-Fri 8.30am-5.30pm' bays.
 - g. **Salcombe Drive**, south side, outside No. 1 Salcombe Drive for 5.6 metres, replacing existing 'Resident Permit Holders Only Zone CH Mon-Fri 8.30am-5.30pm' bays.
 - h. **Coombewood Drive**, west side, outside No. 30 Coombewood Drive for 5.5 metres, replacing existing 'Resident Permit Holders Only Zone CH Mon-Fri 8.30am-5.30pm' bay.
 - i. **Stevens Road**, south side, outside Nos. 117-123 Stevens Road, replacing existing 'Resident Permit Holders Only Zone CH Mon-Fri 8.30am-5.30pm' bay.

 - a. **Valence Avenue**, east side, outside Nos. 553-557 Valence Avenue for 16.7 metres, replacing existing 'Resident Permit Holders Only Zone CH1 Mon-Fri 8.30am-5.30pm' bays and 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
15. Introduce a 'Payment Parking (TC2) Mon-Fri 8.30am-5.30pm Max stay 4 hours No return within 2 hours / Permit Holders Only Zone SGV Mon-Fri 8.30am-5.30pm' bay, the current charges applicable being those set out in this Order, at the following locations:
 - a. **Stockdale Road**, east side, south of No. 2 Stockdale Road for 11.5 metres, replacing existing 'Resident Permit Holders Only Zone SGV Mon-Fri 8.30am-5.30pm' bays.

- b. **Stockdale Road**, west side, south of No. 1 Stockdale Road for 16.3 metres, replacing existing 'Resident Permit Holders Only Zone SGV Mon-Fri 8.30am-5.30pm' bays.
- 16. Introduce a 'Resident Permit Holders Only Zone CH Mon-Fri 8.30am-5.30pm' bay, the current charges applicable being those set out in this Order, at the following locations:
 - a. **Grantham Gardens**, north side, outside Nos. 1-15 Grantham Gardens for 28 metres, replacing existing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
 - b. **Grantham Gardens**, east side, outside Nos. 26-28 Grantham Gardens for 4 metres, replacing existing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions
 - c. **Grantham Gardens**, east side, outside Nos. 18-20 Grantham Gardens for 3.6 metres, replacing existing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions
 - d. **Grantham Gardens**, east side, from a point 3.6 metres south of the southern boundary of Nos. 18-20 Grantham Gardens for 7.5 metres in a southerly direction, replacing existing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
- 17. Introduce a 'Payment Parking (TC1) Mon-Fri 8.30am-5.30pm Max stay 4 hours No return within 2 hours / Permit Holders Only Zone TH Mon-Fri 8.30am-5.30pm' bay, the current charges applicable being those set out in this Order, at the following locations:
 - a. **Renwick Road**, east side, from a point 40 metres north of the junction with Choats Road for 93 metres, replacing existing 'Resident Permit Holders Only Zone TH Mon-Fri 8.30am-5.30pm' bays
- 18. Revoke part of the 'Resident Permit Holders Only Zone CH1 Mon-Fri 8.30am-5.30pm' restrictions at the following locations:
 - a. **Lichfield Way**, southeast side, outside No. 94 Lichfield Way for 6.1 metres
- 19. For the length of **Valence Avenue**, both sides, between its junctions with Wood Lane and its junctions with Mayfield Road and Kemp Road, introduce 'Resident Permit Holders Only Zone CH1 Mon-Fri 8.30am-5.30pm' bays fully on the road, replacing existing 'Resident Permit Holders Only Zone CH1 Mon-Fri 8.30am-5.30pm' bays fully on the footway and existing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
- 20. Revoke part of the 'Resident Permit Holders Only Zone BEC Mon-Fri 8.30am-5.30pm' restrictions at the following locations:
 - a. **Stamford Road**, south side, outside No.187 Stamford Road for 5.2 metres.
 - b. **Rugby Road**, south side, outside No. 263 Rugby Road for 5.3 metres.
 - c. **Rugby Road**, south side, outside No. 281 Rugby Road for 5 metres.
 - d. **Goresbrook Road**, north side, outside No. 230 Goresbrook Road for 4.4 metres.
- 21. Introduce 'No waiting Mon-Fri 8.30pm-4pm' restrictions at the following locations:
 - a. **Oval Road North**, north side, outside no. 75 for 4.8 metres, replacing existing 'Resident Permit Holders Only Zone BM Mon-Fri 8.30am-4pm' bay
- 22. Revoke part of the 'Resident Permit Holders Only Zone HWS Mon-Fri 8.30am-5.30pm' restrictions at the following locations:
 - a. **Connor Road**, southeast side, outside No. 64 Connor Road for 9.3 metres.
- 23. Revoke part of the 'Resident Permit Holders Only Zone STR Mon-Fri 8.30am-5.30pm' restrictions at the following locations:
 - a. **Verney Road**, west side, outside No. 54 Verney Road for 4.9 metres.
- 24. Introduce 'Resident Permit Holders Only Zone STR Mon-Fri 8.30am-5.30pm' bays at the following locations:
 - a. **Parsloes Avenue**, north-east side footway, opposite Nos. 343-347 for 15.8 metres.
 - b. **Goring Gardens**, adjacent to No. 764 Longbridge Road for 7.9 metres, replacing 'No waiting Mon-Fri 8.30am-5.30pm' restrictions.
- 25. Revoke 'Payment Parking (TC2) Mon-Fri 8.30am-5.30pm Max stay 4hrs No return within 2hrs/Resident Permit Holders Only Zone TH Mon-Fri 8.30am-5.30pm' bays on **Renwick Road**, west side, outside Time House.
- 26. Revoke 'Resident Permit Holders Only Zone TH Mon-Fri 8.30am-5.30pm' bays on **Renwick Road**, east side, outside Warehouse 25-27 Renwick Road.

OFF-STREET AMENDMENTS

- 27. Axe Street Service Road Area Car Park will be amended to include areas not previously included in the Off-Street Area where "Off-Street Payment Parking (TC1) Max stay 4hrs No return within 2hrs" bays and "Disabled Blue Badge Holders Only" bays will be introduced. Within this car park area, where parking is not permitted it will be marked on-street with yellow hatching and these areas must be kept clear at all times.
