TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF BARKING AND DAGENHAM (OFF-STREET PARKING PLACES) AMENDMENT NO. *) ORDER 202*

The Council of the London Borough of Barking and Dagenham in exercise of their powers under Sections 6, 32, 33, 35 and 124 and Parts I to IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") as amended by the relevant provisions of the Local Government Act 1985 the Parking Act 1989 and all other enabling and amending legislation and enabling powers, and after consultation with the Commissioner of Police of the Metropolis in accordance with Part IV of Schedule 9 of the Act, hereby make the following Order:

1. This Order shall come into operation on and may be cited as The London Borough of Barking and Dagenham (Off-Street Parking Places) (Amendment No. *) Order 202*.
2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order.
4. In this Order, the "Principle Order" shall mean The London Borough of Barking and Dagenham (Off-Street Parking Places) Order 2017 (as amended).
5. The Principle Order shall be amended by the items shown as No. 1/3, 1/8 and 1/57 in columns 1 to 12 of Schedule 1 to this Order replacing that item in Schedule 1 of the Principle Order.
6. The charges applicable to permits is as set out in the Principle Order Schedule 4, subject to any subsequent changes by Notice of Variation. The Permit Charges shown in Schedule 2 to this Order sets out the Principle Order Schedule 4 charges on the date this Order comes into effect.
7. The following definitions shall be inserted after Article 3(1) of the Principle Order:
"Electric Vehicle Charging Place" means a parking bay designed for use by Electric Vehicles in order to recharge their supply by using a Recharging Point;
"Recharging point" means a device designed for the recharging of an Electric Vehicle;
8. The Principle Order shall be amended by the insertion of the following after Article 9(2)(f):
(g) in an electric vehicle charging place, if it is not an electric vehicle connected to an electric vehicle recharging point and charging.
9. Article 32 (3) of the Principle Order shall be replaced by the following:
(3) No person shall cause or permit a vehicle, other than an electric vehicle connected to an electric vehicle recharging point, to be parked in any parking place indicated as an electric vehicle charging place.

- (14) An additional charge of £1.10 will be applied to all of Items 1/2 and 1/3 Up to 6 hours, Up to 8 hours and Up to 12 hours parking payments and items 1/10, 1/11, 1/40 and 1/50 Up to 4 hours parking payments, and all of Items 1/3 Overnight 8pm-8am Sun-Thurs and Overnight 8pm-8am Fri-Sat parking payments for diesel vehicles that do not meet Euro 6 emission standards.
