## THE LONDON BOROUGH OF BARKING AND DAGENHAM (ELECTRIC VEHICLE PARKING RESTRICTIONS) (VARIOUS ROADS, BARKING AND DAGENHAM) AMENDMENT No. \* ORDER 202\*

## THE LONDON BOROUGH OF BARKING AND DAGENHAM (OFF-STREET PARKING PLACES) AMENDMENT No. \* ORDER 202\*

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barking and Dagenham in exercise of its powers under sections 6, 32, 33, 35, 45, 46, 49 and 124 and Parts I to IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended (hereinafter called "the Act") and all other enabling legislation and powers and after consultation with the Commissioner of Police of the Metropolis in accordance with Part IV of Schedule 9 of the Act propose to make the above Order, the effect of which will be to:

### ON-STREET AMENDMENTS

1. Introduce 'Electric Vehicle Charging Only 8.30am-8.30pm Max stay 4hrs No return within 2hrs/Electric Vehicle Charging Only 8.30pm-8.30am' bays at the following locations:
  - a. **Kennedy Road**, south-east side, adjacent to No. 85 Sparsholt Road, for 21.5 metres in a north-easterly direction, replacing 'Resident Permit Holders Only Zone L Mon-Sat 8.30am-9pm' bays.
  - b. **Lansbury Avenue**, north side, adjacent to No. 64 Morley Road, for 20.7 metres.
  - c. **Roberts Place**, east side, adjacent to 181 Blackborne Road, for 20 metres, replacing part of the 'Resident Permit Holders Only Zone HW2 Mon-Sat 8.30am-5.30pm' bays.
  - d. **Rothwell Road car park**, south side, outside 62-64 Rothwell Road, for 10 metres, replacing part of the 'Resident Permit Holders Only Zone BEC Mon-Fri 8.30am-5.30pm' bays.
  - e. **Sheppey Road**, west side, from a point 6.5 metres north of its junction with Woodward Road for 20 metres in a northerly direction, replacing part of the 'Resident Permit Holders Only Zone BEC Mon-Fri 8.30am-5.30pm' bays.
  - f. **Uplands Road**, north-west side, from a point 14.2 metres north-east of its junction with the north-south section of Uplands Road for 19.5 metres in a north-easterly direction.
  - g. **Uvedale Road**, east side, outside Clynes House and Steadman House, for 20 metres, replacing part of the 'Resident Permit Holders Only Zone WB Mon-Fri 8.30am-5.30pm' bays.

### OFF-STREET AMENDMENTS

2. Bobby Moore Way Car Park will be amended to include 'Off-Street Electric Vehicle Charging Only Max stay 4hrs No return within 2hrs' bays, replacing 4 Off-Street Red Permit Holders Only.
3. London Road Multi-Storey Car Park will be amended to include 7 'Off-Street Electric Vehicle Charging Only Max stay 4hrs No return within 2hrs' bays.
4. Gosfield Road Car Park will be amended to include 'Off-Street Electric Vehicle Charging Only 8.30am-8.30pm Max stay 4hrs No return within 2hrs/ Off-Street Electric Vehicle Charging Only 8.30pm-8.30am' bays, replacing 4 Off-Street Resident Permit Holders Only Zone RCS Mon-Fri 8.30am-5.30pm.
