TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF BARKING AND DAGENHAM (7.5T WEIGHT RESTRICTION) (HEATH ROAD AND SURROUNDING AREA, DAGENHAM) ORDER 202*

The Council of the London Borough of Barking and Dagenham in exercise of their powers under Sections 6 and 124 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling and amending legislation and powers and after consultation with the Commissioner of Police of the Metropolis in accordance with Part IV of Schedule 9 of the Act, hereby make the following Order:-

1. This Order shall come into operation on _____ and may be cited as The London Borough of Barking and Dagenham (7.5T Weight Restriction) (Heath Road and Surrounding Area, Dagenham) Order 202*.

2. In this Order:

"Goods" means objects too heavy or bulky to be carried very far by hand and this includes Postal Packets of any description;

"Goods Vehicle" has the same meaning as in Schedule 1 of the Regulations;

"Maximum Gross Weight" has the same meaning as in Schedule 1 of the Regulations of 2016;

"the Regulations of 2016" means the Traffic Signs Regulations and General Directions 2016 (as amended);

"Traffic Sign" means a sign of any size, colour and type prescribed or authorised under or having effect as though prescribed or authorised under Section 64 of the Act;

"Vehicle" means a Motor Vehicle or a Trailer and "Motor Vehicle" and "Trailer" have the same meaning as in section 136 of the Act and includes any part of a Vehicle.

3. No Goods Vehicle, the Maximum Gross Weight of which exceeds 7.5 tonnes, shall use the lengths of road specified in the Schedule to this Order, except for loading.
4. Nothing in Article 3 of this Order shall;
 - (a) prevent any persons from causing any vehicle to enter any of the prohibited roads for the purpose of loading and unloading in any of the prohibited roads or in any road accessible only therefrom or for the purpose of gaining access to off-street garaging accessible only from any of the prohibited roads; or
 - (b) apply to a vehicle being used in the service of a local authority in pursuance of statutory powers or duties provided that in all the circumstances it is reasonably necessary in the exercise of such powers or in the performance of such duties for that vehicle to enter any of the prohibited roads; or

- (c) apply in relation to any vehicle being used in connection with maintenance, improvement, reconstruction, cleansing or lighting of any of the prohibited roads or of any road accessible only therefrom, or the laying, erection, alteration or repair of any sewer thereunder or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunication system thereunder or thereon, or the placing, maintenance or removal of any traffic sign thereon; or
- (d) apply to vehicles being used for fire brigade, ambulance or police purposes if the observance of any provision of this Order would hinder the use of the vehicle for the purpose for which it is being used on that occasion; or
- (e) apply to anything done with the permission or at the direction of a police constable in uniform; or
- (f) apply to any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to section 66 or section 67 of the Act.
